Limitations and Exclusions

Unless otherwise shown below, these exclusions apply to You, Your Traveling Companion, or Family Member scheduled and booked to travel with You.

The following exclusion(s) appl(y)(ies) to the Trip Cancellation and Trip Interruption and Medical Expense.

We will not pay for any loss or expense caused due to, arising or resulting from:

1. a Pre-Existing Medical Condition, as defined in the certificate.

The following exclusions apply to the Medical Expense benefits.

We will not pay for any loss or expense caused due to, arising or resulting from:

 routine physical examinations or routine dental care;
 traveling for the purpose or intent of securing medical treatment or advice;

Alcohol or substance abuse or treatment for the same;
 Normal pregnancy (except Complications of Pregnancy) or

childbirth, or elective abortion;

5. Your participation in Adventure or Extreme Activities, riding or driving in races, or participation in speed or endurance competition or events, except as a spectator.

Trip Cancellation: Reimburses up to the Maximum Benefit Amount shown in the Schedule of Benefits, to reimburse You for the unused non-refundable Prepaid Payments You paid for Travel Arrangements when You must cancel Your Trip due to a covered reason.
